

**GAME BRAIN “HOUSE OF WISDOMS” CONTEST 2020 (the “CONTEST”)
OFFICIAL RULES (the “RULES”)**

THIS CONTEST IS OPEN TO ONTARIO RESIDENTS ONLY AND IS GOVERNED BY ONTARIO LAW. NO PURCHASE NECESSARY.

By entering in this Contest, participants agree to be bound by these rules and by the decisions of the Responsible Gambling Council (Ontario) (the “**Sponsor**”), which are final in all matters relating to the Contest.

This Contest is in no way sponsored, endorsed or administered by, or associated with, Facebook or Instagram. Contest participants (“**Participants**”) are providing their information to the Sponsor and not to Facebook or Instagram. Participants agree that Facebook and Instagram are released of all responsibility for and any liability in regard to this Contest. The information participants provide will be used to administer this contest only and will not be used for other purposes or shared with any third party with the exception of service providers who are assisting Sponsor with the administration of the Contest.

1. CONTEST PERIOD

The Contest will begin on November 23, 2020 at 8:00 am Eastern Time (“ET”) (“**Contest Start**”) and end on January 17, 2021 at 11:59 pm ET (“**Contest Close**”; the period commencing on the Contest Start and ending on the Contest Close is referred to as the “**Contest Period**”).

2. ELIGIBILITY

Contest is open to all legal residents of Ontario, Canada who are between the ages of 13 and 18 years at the time of entry. If a Participant has not reached the age of 18, his or her parent or legal guardian must agree to these Contest rules along with and on behalf of his or her minor child. All rights and responsibilities of a minor under the Contest rules are conferred to and assumed by the minor’s parent or legal guardian in representation of the minor.

Employees, representatives or agents (and those with whom such persons are domiciled, whether related or not) of the Sponsor, its affiliates, prize suppliers, advertising/promotion agencies and any entity involved in the development, production, implementation, administration, judging or fulfillment of the Contest (collectively, the “**Contest Parties**”) are not eligible to enter.

3. HOW TO ENTER

No purchase is necessary to enter.

To enter into the Contest and be eligible for the prize described below, participants must, during the Contest Period: 1) play the 3 games (Vortex of Loss, Room 19-9-7-14-19 and Redoubt of Reality) featured in the “House of Wisdoms” digital game and 2) complete an entry form (the “**Entry Form**”) found at the end of the final game. One (1) entry into the Contest (each, an “**Entry**”) will be provided each time “House of Wisdoms” digital game is played and the Entry Form completed, both during the Contest Period, up to a maximum of three (3) times. The Entry Form includes two (2) survey questions which must be answered for an Entry to be valid. All Entry Forms must be fully and accurately completed to enter (including first and last name and a valid email address). Participants must provide a personal e-mail address and may not provide the address to a shared e-mail account. Incomplete or inaccurate Entry Forms are void and the related Entry will be disqualified. The Sponsor is not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).

4. PRIZE

There will be four (4), \$500 CAD gift prizes (, a “**Prize**”)

5. DRAWS

Prize winners (each, a **“Winner”**) will be determined by a random draw (the **“Draw”**) from all eligible Entries received on or before the Contest Close. Selected winners will be required to answer a mathematical skill testing question without mechanical or other assistance.

Odds of winning will vary depending on the total number of eligible Entries received.

6. FULFILLMENT

The potential contest winners will be contacted via email by a Sponsor representative. The potential contest winners will be required to provide to Sponsor proof of eligibility, including proof of age and Ontario residence. Failure by a potential contest winner to provide such proof to the reasonable satisfaction of the Sponsor in a timely manner may result in his or her disqualification in the sole and absolute discretion of the Sponsor. If a potential contest winner cannot be contacted, fails to respond to Sponsor's attempts to connect or cannot provide proof of eligibility within fourteen (14) days of the Draw, the potential winner will forfeit his or her entitlement to a Prize and Sponsor will conduct a further random draw to select another individual from remaining eligible Entries. A Prize will not be awarded in the event there are no eligible Entries for the Draw or no remaining eligible Entries for any subsequent draw.

WITHIN 14 DAYS FROM RECEIVING NOTICE THAT HIS OR HER NAME WAS DRAWN, THE WINNER WILL BE REQUIRED TO SIGN AND DELIVER TO THE SPONSOR A SIGNED AFFIDAVIT OF ELIGIBILITY AS WELL AS SIGN A DOCUMENT CONFIRMING ACCEPTANCE OF THESE CONTEST RULES AND RELEASING THE CONTEST PARTIES FROM ANY LIABILITY WITH RESPECT TO THE CONTEST AND RECEIPT AND USE OF THE PRIZE. WINNERS WHO ARE YOUNGER THAN 18 YEARS OF AGE MUST HAVE A PARENT OR LEGAL GUARDIAN SIGN AND DELIVER SIMILAR DOCUMENTATION WITHIN THE SAME PERIOD OF TIME.

The Prize must be accepted as awarded. There will be no substitution for prizing made except as provided herein at Sponsor's sole discretion. Sponsor is not responsible for lost or stolen Prizes and will not replace same.

7. GENERAL

All Entries become the property of the Sponsor.

This Contest is subject to all applicable federal, provincial and municipal laws.

ANYONE DETERMINED TO BE IN VIOLATION OF THESE RULES FOR ANY REASON IS SUBJECT TO DISQUALIFICATION IN THE SOLE AND ABSOLUTE DISCRETION OF THE SPONSOR AT ANY TIME.

The Sponsor will not be liable for: (i) any failure of any website, online platform or app during the Contest Period or thereafter; (ii) any technical malfunction or other problems relating to the telephone network or lines, computer on-line systems, servers, access providers, computer equipment or software; (iii) the failure of any Entry to be received, captured or recorded for any reason, including, but not limited to, technical problems or traffic congestion on the internet or at any website; (iv) any injury or damage to an entrant's or any other person's computer or other device related to or resulting from participating in the Contest; and/or (v) any combination of the above.

In the event of a dispute regarding the identity of the person who submitted a Contest Entry, Contest Entries will be deemed to have been submitted by the authorized account holder of the email address associated with the correctly completed Entry. An entrant may be required to provide proof (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) that he/she is the authorized account holder of the email address associated with the Entry in question.

The Sponsor reserves the right, to withdraw or suspend this Contest (or to amend these Rules) in any way, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Rules.

Any attempt to deliberately damage any website or to undermine the legitimate operation of this Contest in any way (as determined by Sponsor in their sole and absolute discretion) may constitute a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law.

By entering this Contest, each participant expressly consents to the Sponsor, its agents and/or representatives, storing, sharing and using the personal information submitted with his/her Contest Entry only for the purpose of administering the Contest and for the limited promotional purposes set forth in these Rules, and in accordance with Sponsor's privacy policy (available at www.responsiblegambling.org/privacy-policy), unless the participant otherwise agrees.

The Sponsor reserves the right, in their sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any Participant or Entry with these Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules, or for any other reason.

By entering the Contest, Participants are granting permission for their name, city or town of residence, to be used in any promotional material in the event they are chosen as a winner.
